Note:-

1. The examination forms/fee of only those students will be forwarded to the Examination Branch who complete prescribed attendance in lectures / practicals /tutorial etc. upto the last date of submission of forms/fee without late fee. Such students will have to continue to attend the classes even thereafter to maintain the said percentage of attendance failing which they will not be allowed to appear in the examination.
In case any student fulfils the attendance requirement upto later date, his/her examination form & fee will be accepted with late fee as per schedule.
2. The examination forms/fee received after the last date (without late fee) due to any reason, will be accepted with late fee as per schedule.
3. In case of late declaration of result of same class where the student is not at fault, no late fee will be charged upto 10 days. Thereafter, applicable late fee will be charged.
4. If last date for submission of examination form/ fee falls on holiday, the next working day will be treated as last date for the purpose.
5. In case the Practical Examination is already over and Examination form/fee is submitted late, the student will be treated absent in the practical examination His/her request to conduct special practical exam will be considered as per rules.
6. The Schedule of Examination in respect of P.B.B.Sc Nursing Exam will be issued separately.
