### NOTIFICATION

"The University shall obtain accreditation from the National Assessment and Accreditation Council, Bangalore or Nation Board of Accreditation within five years of its establishment and inform the Government and such other regularly bodies which are connected with the courses taken up by the university about the grade provided by the said accreditation bodies to the university. The University shall get renewed such accreditation at an interval of every five years thereafter or as per norms of the concerned accreditation bodies".
