OFFICE ORDER

Subject: Temporary Suspension of Single-Room Accommodation and Reallocation of Hostel Rooms.

This is to notify all concerned that, owing to a current shortage of vacant hostel rooms and the necessity to ensure fair and equitable accommodation for all eligible students, it is decided that the temporary suspension of the single-room occupancy facility with immediate effect, until further notice.

In view of the above, the following directives are hereby issued for strict compliance by all concerned:

- 1. Mandatory Relocation:** Students presently occupying single rooms are required to shift to alternative accommodation within **30 days** from the issuance of this order.
- 2. Reallocation Options:** Affected students will be reallocated to either:
 - A double-sharing room within their existing hostel.
 - Another hostel where accommodation is available, as allotted by the Hostel Administration.
- 3. Process of Allocation:** Room reallocation will be carried out in an orderly and non-discriminatory manner, subject to administrative feasibility and room availability.
- 4. Financial Adjustments:** Any difference in hostel charges arising from the change in room category or hostel allocation will be adjusted in the respective student's account in accordance with applicable financial procedures. Excess amounts already paid will be adjusted against future hostel dues or refunded, as applicable.

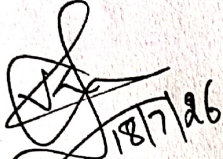
