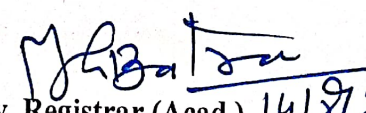

The last dates for submission of articles are 31 August 2026 for the State/UT Level Competition and 30 September 2026 for the National Level Competition.
