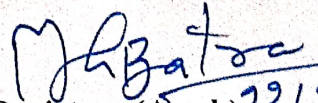
Please find enclosed herewith a copy of letter No. Edu-2/2026/11074-80 dated 15-09-2026 on the above subject.

- a) Student Application Submission: 09.09.2026 to 31.01.2027
- b) Institute Verification: Open up to 10.02.2027
- c) Defective Application Verification: Open up to 10.02.2027
- d) DNO Verification: Open up to 20.02.2027

In view of the importance of ensuring that no eligible student is deprived of the
benefit of scholarship due to lack of information or non-submission of application, all concerned
Scheme Implementing Departments are directed to ensure 100% coverage of all eligible
students under their respective jurisdiction.
